AN ACT of the County Assembly of Laikipia to amend the Laikipia County Enterprise Fund, 2014, and for connected purposes

ENACTED by County Assembly of Laikipia, as follows—

- 1. This Act may be cited as the Laikipia County Enterprise Fund (Amendment) Act, 2018.
 - 2. In this Act, unless the context otherwise requires—

"principal act" means the Laikipia County Enterprise Fund Act, 2014.

- 3. Section 2 of the Principal Act is amended by *deleting* the words "Enterprise Development" and *substituting* therefor the word "finance".
 - 4. Section 12 of the Principal Act is amended as follows—
 - (a) in subsection (1) by deleting the subsection and substituting therefor with—
 - 12 (1) The County Executive Member shall let the Loan Security Conditions with the approval of the County Assembly;
 - (b) in subsection (2) deleting the subsection and substituting therefor with—
 - 12 (2) the interest rate will be 6% and may be revised from time to time by the County Executive Member with the approval of the County Assembly.
 - 5. Section 13 of the Principal Act is amended as follows—
 - (a) in subsection 1 by *deleting* the word "appoint" and *substituting* therefor the words "competitively source" and by *deleting* the word "administer" and *substituting* therefor the word "manage" and *inserting* the words "with the approval of the County Assembly" immediately after the word "repayments;"
 - (b) in subsection 2 by *deleting* the words "upon approval by" and *substituting* therefor the words "in consultation with"
